- Graduate degree in public policy, public administration, sociology, law, or related field (Ph.D. or J.D. **strongly** preferred)

- Quantitative data analysis skills using spreadsheets (Excel), statistical analysis software (SPSS, R, etc.), geographic information systems (ArcGIS, QGIS, etc.), and interactive data visualization (Tableau Public, Google Fusion Tables)
- Familiarity with state legislative process, and state and federal data sources
- Excellent written and verbal communications skills, including ability to communicate complex information to non-expert audiences
