

Public Notice Park City Communities

April 4 - April 15, 2016, Park City Communities (PCC) will be accepting Preliminary Applications for the Housing Choice Voucher (HCV) Program (formerly known as Section 8). HCV is a Federally-funded program that offers rent subsidies to low-income families and individuals so they may have access to decent, safe, and sanitary housing.

Pre-applications will be available for download on our website www.parkcitycommunities.org from **April 4 – April 15, 2016**. Many public libraries offer free computer access if you don't have personal access to a computer. Please note branch hours vary by location. The pre-application will be published in the newspaper April 4-6, 2016. **A limited number of applications will also be available for pick-up only at the following locations:**

No telephone calls, walk-ins or drop off applications will be accepted.

Only one pre-application per family will be accepted; if duplicate pre-applications are submitted for one household; the household will be disqualified. Any pre-application that is not signed, fully completed or has a postmark date prior to April 4 or after April 15, 2016 will not be accepted. Incomplete applications will not be included in the lottery and will be discarded. PCC will not be responsible for pre-applications lost/delayed through the mail.

Please note that all household members are subject to a criminal background check. All households must also meet all U.S. Department of Housing and Urban Development (HUD) income and eligibility requirements. Maximum income levels based on family size are as follows:

Park City Communities will use a Random-Draw Lottery System to determine the order of each pre-application on the waiting list and a maximum of 2500 pre-applications will be drawn. The random lottery will be held on May 13, 2016.

Those chosen in the lottery will be notified by mail no later than June 3, 2016. All disqualified and remaining applications not selected will be discarded with no further notice. Therefore, if you do not receive a letter by June 3, 2016, your pre-application was not drawn and you will not be placed on this waiting list.
